- III. Approval of Meeting Minutes, 21 November 2019: Approved.
- IV. Report by the Chair
  - i. APIL: The Chair provided the following meeting summary of the APIL Meeting held in Saipan on 3 Dec 2019:
    - 1. APIL recognizes the following partners: Pacific Island Development Bank; Ayuda Foundation; and Payuta)
    - 2. APIL noted a verbal presentation by Payuta regarding its progress with the 2019 Non-Profit Congress and it's initiatives to improve collaboration with the Government of Guam, which is in-line with the Sustainable Development Goal (SDG) 17.
    - 3. For the next APIL meeting, noted that APIL invited partners to submit proposed resolutions for APIL endorsement, so that any resolution can be submitted by APIL on behalf of Payuta. This process will also allow APIL to track and provide updates on the resolutions.
    - 4. Noted the next APIL General Assembly will be held in Hawaii Legislature during 2020 Fest Pac.
    - 5. Noted the Vice-Chair also attended the APIL meeting, who reported that Hawaii is reaching out to Guam NGOs, who participated in the organization of FestPac 2012, and is seeking any assistance.
    - 6. Noted that several National Liaison Units or Umbrella NGOs have formalized partnerships between government and CSOs (e.g. Marshall Islands, Palau) and noted that Payuta should consider the same approach.
    - 7. Noted APIL's request for Payuta to consider assisting other Micronesia island states in strengthening their NPOs. Noted that the Non-Profit Congress has been the vehicle in the past to provide technical assistance trainings.
    - 8. Noted that Payuta members can assist in addressing specific SDGs, e.g. Food Security-Farm To Table.
    - 9. Noted that APIL is receptive to receiving proposals to help fund strategic regional goals and objectives
